VILLAGE OF ANNA, OHIO
ORDINANCE NO. 1646-13

**AN ORDINANCE AMENDING ORDINANCE NO. 1545-09 AND INCLUDING A MORE IN-DEPTH
SNOW AND ICE REMOVAL PROGRAM FOR STREETS AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Anna's Ordinance 1545-09 needs amending to include a more in-depth snow and ice removal program for streets; and

WHEREAS, the Village Council feels that this policy will help improve the safety of its residents and others traveling within the Village limits:

NOW, THEREFORE, be it ordained by the Council of the Village, a majority of the members elected thereto, concurring herein:

Section 1

Ordinance No. 1545-09 includes Exhibit A and it states:

During snow/ice events of any plowable amounts there is "NO PARKING" on the streets by Village Ordinance 1545-09. Failure to move a vehicle could result in having it towed at the owner's expense.

Section 2

Amend section to:

During snow/ice events of two inches or more, vehicles must be moved to allow for plowing of streets for the safety of residents and others traveling within the Village limits.

On the even number day of the month, vehicles may be parked on the street where building addresses end in an even number; and on the odd numbered day, the odd side, where parking is lawfully allowed, until the snow is removed. In this way, within two days the whole street will be plowed all the way to the curb. Once plowed, vehicles may park on either side.


Upon the first violation of this Ordinance, the owner will receive a warning. Upon the second violation, he/she will receive a ticket, and upon the third violation, the vehicle will be towed at the owner's expense.


Section 3
